### **Terms & conditions**

- 1. You must have been a full member of the AJC for a period of at least 6 months as of 1 April 2021 and have paid your subscription for the year 2021/22 to be eligible to apply.
- 2. You must be delivering charitable services in Jersey and your answers above must relate to your Jersey services any award must be used exclusively in Jersey.
- 3. A maximum of £500,000 is available in the 50@50 award fund and a maximum of £10,000 may be awarded to any charity. Where charities are part of a group, a maximum of £10,000 may be awarded to that group.
- 4. In the event that applications are received which exceed the amount available, the AJC will prioritise those charities where £10,000 would make the greatest difference.
- 5. The AJC is under no obligation to distribute any or all of the award fund and in the event that insufficient applications are received to warrant an award, the balance may be carried forward or returned to general grant funds at the AJC's discretion.
- 6. Awards made are unrestricted and may be used for any charitable purpose in Jersey. You do not need to tell us in advance how you intend to spend any award but by completing this application you undertake to report to us no later than 6 months from receipt, what difference it has made to your organisation.
- 7. An award under the 50@50 scheme will not affect your eligibility to apply for a grant from the AJC or be taken into account when calculating the maximum award from CI Lottery or private donor funds distributed by the AJC.
- 8. The closing date for applications is 31 August 2021. Any received after that date will not be considered.
